### What is the purpose of this update?

This document tells you how the GoalsGetter Generate Thematic Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund aims to provide a higher return over the long term by investing in an actively managed portfolio of growth assets predominately made up of mid-large cap international equities with a very minor allocation of income assets.

# What are the risks of investing? Risk indicator for the GoalsGetter Generate Thematic Fund

Nikko AM is relying on the Financial Markets Conduct (Market Index) Exemption Notice 2018 and have created a composite index in order to calculate the market index annual return. The Manager believes the use of a composite benchmark for these funds would be useful to investors in assessing the performance of the fund as a whole. The composite market index for each fund is made up of the index of the underlying sector funds (where an Appropriate Market Index or Peer Group Index is available) multiplied by the respective target investment mix. # Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Sam made the first investment of \$10,000 in the fund and did not make any further contributions. As at 30 June 2024, Sam received a return after fund charges were deducted of \$495 (that is 4.95% of his initial \$10,000). Sam also paid \$5 in other charges. This gives Sam a total return after tax of \$467 for the period ending 30 June 2024.<sup>2</sup>




### What does the fund invest in?<sup>3</sup>
