
Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$592 (that is 5.92% of his initial \$10,000). Simon also paid \$30 in other charges. This gives Simon a total return after tax of \$393 for the year.²
