## Changes relating to the scheme

On 1 June 2023, a replacement Product Disclosure Statement (PDS) was issued for the Nikko AM Global Equity Funds to capture the following changes:

- Name of Global Equity Unhedged and Hedged Funds amended to Global Equity Multi-Manager Unhedged Fund and Global Equity Multi-Manager Hedged Fund

On 1 June 2023 an updated SIPO was issued for the Scheme to reflect:

- Hedging ranges for Global Shares and Global Equity Hedged Funds
- Benchmark change Property Fund
- Update of benchmark name Global Bonds

On 3 July 2023, the following replacement PDS' were issued:

- Nikko AM Diversfied Funds SAA changes
- Nikko AM Income Fund SAA change
- Nikko AM Domestic Equity Funds updated description of the Concentrated Equity Fund performance fee
- Nikko AM ARK Disruptive Innovation Fund minor amendment to risk indicator description.
- Nikko AM Cash and Fixed Interest funds change of benchmark index name for the Global Bond Fund.

On 3 July 2023 an updated SIPO and OMI were also issued to reflect these changes. Also included in these updates were update of Directors and Investment team and Investment Committee members, change of benchmark for the Nikko AM Wholesale Property Fund, removal of reference to the Nikko AM Wholesale Option Fund and hedging changes for Global Shares Hedged and Global Equities Hedged Fund mandates.

On 27 September 2023 a replacement PDS for the Nikko AM Freedom Fund was issued. The following changes were made:

- new SAA for the fund
- Revised risk indicator

A updated Freedom Fund OMI was issued on the same day which updated the example of expected returns for the fund.

On 9 October 2023, Alan Clarke was appointed as Portfolio Manager, External Managers and Diversified Funds

An updated OMI was issued for the Scheme on 17 October 2023 to reflect key personnel changes in the business:

An updated SIPO was issued on 12 December 2023 due to a mandate change for both the Nikko AM Wholesale NZ Bond and Wholesale NZ Corporate Bond Funds

Owen Batchelor was appointed as Portfolio Manager, Wholesale Property Fund on 1 April 2024.
