# NIKKO AM CONCENTRATED EQUITY FUND

**Fund Update** 



## What is the purpose of this update?

This document tells you how the Nikko AM Concentrated Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

This is a replacement Quarterly Fund Update issued on 27 March 2025 to update past year and average over 5-year performance. This was overstated previously due to a unit pricing error where the performance fee for the fund was not correctly reflected in the unit price. The unit price of the fund was affected for the period 1 October 2024 to 4 March 2025.

# Description of this fund

The fund aims to outperform the RBNZ Official Cash Rate plus 5.0% per annum over a rolling three-year period before fees, expenses and taxes. This fund aims to provide investors with concentrated exposure to New Zealand and Australian equity markets from an actively managed investment portfolio.

# What are the risks of investing? Risk indicator for Nikko AM Concentrated Equity Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## How has the fund performed?



# Annual Return Graph<sup>1</sup>

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$1,210 (that is 12.10% of his initial \$10,000). Simon also paid no other charges. This gives Simon a total return after tax of \$1,136 for the year.<sup>2</sup>
